- Monthly report available
- 13 Chestnut Ave \$300 in fines, \$150 every week that she doesn't comply, no water since 2015, next court day in March
- Next Thursday is ZBA vote on Solar Farm
- Permits are slower than usual so far this year

- Presbyterian Church closing and selling building, 1902 deeded park to village for public purposes, zoned low density residential, can't be a house
- 36 Spruce Street arrests made, removed garbage

Motion: To buy one Volvo loader with one CAT loader trade-in, but not take the Volvo if the Village doesn't want it. Order one CAT loader and try selling the other CAT loader at auction. Trustee Nagle made the motion and seconded by Trustee Sick. Vote: Trustees Sick, Perkins, Weidrick voted no and Trustee Nagle voted aye. Mayor Vogt present. Motion failed 3-1.

Further discussion. DPW Superintendent Tracy noted that we don't currently know the resale value of the Volvo loaders.

Motion: To order two CAT loaders as long as we are guaranteed we don't have to take them if we don't want to when they come in. Trustee Sick made the motion and seconded by Trustee Nagle. Trustees Perkins, Weidrick, Nagle, Sick and Mayor Vogt all voted aye. Motion passed 5-0.

- Discussed replacement of payloader 908 and mini excavator 306.
   These are budgeted items. \$10,000 for the 908 and \$6,500 for the 306 to trade. Vote on at next meeting
- DPW Superintendent Tracy gave update on water and sewer issues
