## **COMMITTEE REPORTS:**

## LEGISLATIVE - Mayor Haywood

- Partial Exemption Mayor Haywood discussed the Partial Exemption proposed for Firefighters and Ambulance Workers proposed by the Livingsting County Board of Supervisors. Before taking any action, the Mayor will find out more information. A public hearing will be scheduled.
- 2. Investments Discussion was held on investments. After discussion, a motion was made to approve the transfer of \$3,000,000 from general fund to NYClass for investments by Trustee Nagle, seconded by Trustee Wiedrick. Vote: 5-0, approved.
- 3. Intermunicipal Agreement Mayor Haywood stated that we are raising salt price by \$.50.

### VILLAGE CLERK/TREASURER - Mayor Haywood

- Insurance Policy Renewal Clerk/Treasurer Sue Cotter reported that the Village received the renewal policy
  information from Genesee Valley Insurance Agency. She will be meeting with individuals to confirm vehicles
  and equipment listed and any missing.
- 2. Williamson Law Support Fees for 2024 Clerk/Treasurer Sue Cotter reported that fees for Williamson Law will be increasing by 5% in 2024.
- 3. Budget Modification For the Genesee Valley Construction bill, a motion was made by Trustee Sick, seconded by Trustee Perkins to approve the budget modification to move \$58,113.01 from G500 Fund Balance to G8120.211. Vote: 5-0, approved.

- 2. Ambulance Trustee Sick reported that the Ambulance Company will be going to the Genesee Valley Rotary Camp and giving rides on their gator.

- 3. Police Department Chief Griese reported on the Police Department statistics, including arresting 18 people; Labor Day weekend the public will be using the parking lot for a car show, September 2<sup>nd</sup> Farmers Market on Ossian Street, and a Car Wash/Volleyball/Band on Battle Street. Jason Derrenbacher from the Sierra Inn is asking for permission to ride side-by-sides into the Village on October 7<sup>th</sup> for a dice run. State roads would be avoided. Money raised will be donated to an organization that revamps vehicles for veterans. Lucky Number will be holding another band concert on Chestnut Avenue on the 9<sup>th</sup>. The Mayor will verify the date. The Mayor also reported that they approved the school's annual homecoming parade. The school is looking into putting in-school suspension into the GCC building. More information will be shared when available. Need to keep a standard of what the Police Department will handle. New police car is almost ready.
