- Discussion on 2026-2027 Tentative Budget
 - The following changes were made:
 - G8130.421 increased to \$30,000.00
 - G8120.420 decreased to \$30,000.00
 - A7110.120 increased to \$41,335.00
- Public Hearing on 2026-2027 Tentative Budget
 - Motion made by Trustee Button to set public hearing on the 2026-2027 Budget on April 15 at 6PM. Seconded by Trustee Specchio. All in favor. Motion carried 5-0.
